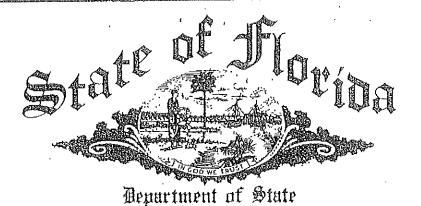

RESTATED ARTICLES OF INCORPORATION OF SUNSET VILLAGE, INC.



ARTICLE 1. NAME

The name and address of the corporation shall be SUNSET VILLAGE, INC, 3401 Gandy Boulevard, Pinellas Park, Florida 33581.

ARTICLE 2. DURATION

The date of commencement of corporation existence shall be the date the Articles were filed with the Department of State and the period of duration of the corporation shall be perpetual.

ARTICLE 3. PURPOSE AND POWERS
