#### 503 Rose, Duane & Sheila Seidel Site Plan Review

Second review of Citrus site plan took place. Confirmation of measurements of lot were discussed. 537 Violet (open lot behind 503 Rose) buildable lot dimensions become 47X67 ft. because of location of utility lines.

Motion: Gary Thrasher made the motion to approve the site plan as presented with the caveat the drawing would be modified to note 8 ft. required frontage from the corner of the unit to the pavement and no roof over on the patio. Motion seconded by Jan McCoy. Motion passed unanimously. SITE PLAN APPROVED.

# <u>058 Avocado – Traci Vassi, Purchase from Wanda Santiago (723 Unit Only) Potential 723 Share</u> Conversion

Vetting complete. Owner was directed by the office to complete purchase of unit only (planned for 11.30/11.31) and then process purchase of a share. Meanwhile, share pricing increased at the 11.13.23 Board meeting. New owner is asking original share cost information be honored. If owner completes unit purchase before Dec 1<sup>st</sup>. they would be considered a 723 resident and could apply for share purchase at old price, based on board resolution.

Motion: Gary Thrasher made a motion to approve the unit purchase and 723 share conversion. Motion was seconded by Jan McCoy. Vote was <u>not</u> unanimous. Greg Jackson requested the scenario be moved to the board of directors for determination at the 11.29.23 board meeting.
