Preliminary limited call for bid (LCB) document, prepared by Dan Noseworthy, was reviewed by the committee, and will be forwarded to our attorney for review. It was modified to address:

- Quote of metal mansure as an option for the mansur., preferred standing seam with no fasteners but it is not available in aqua. White may suffice. Can consider screw-down type 26-29 gauge metal (the lower the gauge the thicker the metal is)
- Provide product samples for all materials to be used in the project (right down to the nails)
- Language for consequences for non-performance, breach of contract (so we don't experience what we have with the wall) and address change orders
- Requirement for a performance bond. The contractor goes to an assurity company who will provide coverage by another contractor if the hired vendor does not complete the job.
- Errors and omissions clause
- Payments will be broken out into thirds (1/3 up front, 1/3 upon completion, 1/3 30-day hold-back upon receipt of closing of permit and passing of inspection.

- We have three quotes for the A/C portion of the job but they will require update.
- Expense for removal and replacement of gutters by a gutter vendor must be determined and incorporated into the project cost.
- Greg is interested in asking a Veteran owned business (Freedom Roofing Division) to quote. We will ask the group to add this business into the process at the next meeting.
- We researched a national roofing company (Nations Roofing) suggested by Larry Smith but they are not local.
- Discussed UV lights in the A/C units (Bill Hickey recommendation). A/C vendors will be asked to quote inclusion.
