Vision: Implementing Priorities Monthly BOD Report March 18, 2024

Report Period: February 28, 2024 – March 18, 2024

- Security was the number one priority identified by the majority of members in the Vision priority ranking.
- On March 3, 2024, Karen Harding and I met with Ralph Payne, Bryant Harding and Don Barnes to get briefing on research and progress of the Security Focus Group, a sub-committee of the Neighborhood Watch Committee. A second meeting with the entire Security Focus Group was held on March 7, 2024. Significant work and progress have been made and it was determined that the Security Focus Group is ready to present findings to the BOD on four security initiatives. The content of the presentation was reviewed with final review scheduled for March 18. Motions are expected to be presented requesting funding and approval for four initiatives. This progress is made possible because of the significant research, volunteer time commitment and expertise of many of the group members. We extend our gratitude for their work.
- On March 13, 2024, a focus group that was held for members to share concerns and propose solutions to improve security in our park. A summary of the discussions is attached and will be available on our website.
- The second priority identified by members was to improve/enlarge the clubhouse. Over the
 past year many concerns have been voiced about the office area in the clubhouse.
 Confidentiality is a key concern. Noise level is another significant concern. All BOD members
 were contacted for individual discussions. All nine members recommend that we explore
 options to relocate the office staff outside the clubhouse. A sub-group will be established to
 explore options and costing.
- A focus group on ideas and suggestions to enlarge/improve the clubhouse is scheduled for March 26, 2024, 9:30-11:30 am in the clubhouse. We will be seeking volunteers to work on specific projects. Sign up sheets are planned to be posted on March 26, 2024.
- Zoom meetings will be posted to ensure residents not in the park can participate. Residents who could not attend a focus group meeting are also welcome.

The Vision: Implementation of Priorities – Security, focus group discussion began 10:30 am.

Notice of the focus group was posted on the bulletin board and emailed to members on March 8, 2024.

Agenda

Pat explained the purpose of the meeting was to provide a forum for members to share concerns with security and to propose solutions to improve security in our park. As articulated in the notice of the meeting, significant research has been completed by the Security Focus Group, a sub-committee of the Neighborhood Watch Committee. The Security Focus Group (2023) will present their information and recommendations at the BOD meeting March 20, 2024:

- Securing the Walmart gate area
- Restricting Park access via open wall areas at 1) Canal & Oleander, and 2) Azalea & Gardenia
- Improvements to the Oleander gate
- Front Entrance Gate

Pat noted that these items will not be discussed today. Members were encouraged to attend the March 20, 2024, BOD meeting for the presentation on these security improvements.

Summary of Security Discussions

- 1. Stop Signs: Concern expressed that vehicles, golf carts and bikers are not stopping at stop signs. All agreed this was a concern. Pat noted that signs 'Seriously Slow Down' that are faded are in the process of being replaced. The Pinellas Police Department has loaned us a speed radar sign to use to alert riders of their speed and encourage self-discipline. The sign is not working but the office has called the police department to request that the sign be fixed. Discussion ensued on the best location for the sign. By a show of hands, decision was to first place the sign on the roadway entering the park. Bill Hickey and Kevin Stewart will determine exact location. Providing the police are willing to move the sign, the second location will be on Canal. Dennis Cook, in consultation with Maggie Stokes, will determine location on Canal. Members were encouraged to report violations using the Complaint Form at the office. Our manager will follow up on complaints.
- Streetlights: Additional street lighting, as recommended by Security Focus Group, is scheduled to be installed in June 2024. Karen reported that the contract for this project has been signed.
- 3. Accessibility: Concern with accessibility to the clubhouse was voiced. The possible purchase of ramps for doors to the clubhouse, for example from clubhouse to pool, is being

investigated by the office. The next Vision focus will be on improving and enlarging the clubhouse. The need for improved access can be addressed with this initiative.

- 4. Night Patrol: the suggestion to introduce a night patrol was presented to the group. ?? noted that several years ago the park did pay for night patrol. This was discontinued when the use of fobs for access to the clubhouse and pool was introduced. Additionally the back gate (Oleander) was added to improve security.
- 5. Emergent Situations: Members reported concern with recent events when police, multiple police cars were in the park and a helicopter was hovering over the park. Members wondered if there was an alert system that could be used to advise when we should stay inside and when the situation was resolved. Pat and Karen agreed to arrange follow up with police to see if they have a community alert system. Suggestion was put forward that individual members could post information on Facebook 3401. It was noted that sharing information in this way might be the fastest way to alert others. Pat noted that the timeliness of posting would depend on a Facebook administrator seeing and approving the post. Pat noted that Facebook 3401 could use additional volunteers.
- 6. Patrols of Park by Manager: It was suggested that if the manager could do regular patrols this would help with safety and security. Karen and Pat confirmed that Marilyn Corazza has begun doing patrols of the park.
- 7. Neighborhood Watch: A member noted that Neighborhood Watch is a good initiative. She noted that we all need to do our part and be vigilant, share information and report.
- 8. Non-compliance with Parking Regulations around pool: a member voiced concern about vehicles not adhering to parking rules. A suggestion was that could we have signs made that all residents could use and place on windshields when they observe parking violation? Discussion ensued about the repercussions. For example, you could break a windshield wiper. Pat and Karen will bring concerns to manager. All members can report violations.

Members were informed that a Zoom Focus Group will be offered for those who are not in the park or could not attend today. The next Vision: Implementing Priorities Focus Group will be on the number two priority — Enlarge/Improve the Clubhouse. Did we give date??? All were reminded of the agenda for Security Focus Group presentation at the BOD meeting March 20, 2024.

Conclusion: Focus Group concluded approximately 11:40 am.
